1. Update on Vulnerability Assessment (VA) - Shawn

- Written draft reports incorporate local data are progressing well
- Focus on 4 sections:
 - i) Vermin & disease
 - ii) Extreme weather
 - iii) Air quality
 - iv) Water & food borne disease
- First draft due by end of the month
- Provides a good starting point for CCWG and CCAP

2. 2nd Town Hall Workshop on Climate Change and Agriculture – Melanie

- Al, Margo and Melanie attended; Jeff provided the CCAP introduction at the beginning group session and Ewa provide the overview and wrap up summary of the findings
- Next venue to focus on Climate Change and Water potentially in fall 2015
- Donna and Atul asked to be included on the organizing committee for this event

3. Overview of Ontario's Land Use Planning Review – Liz

- Margo & Melanie attended the Peterborough Public Meeting, with Liz attending as a facilitator
- 16 public meetings were held across Ontario with a range of attendance from 100 to 400; 110 people attended the Peterborough event
- MPP Jeff Leal opened the meeting, number of speakers, then broke out into 6 different topic areas where the round table chose 2 topics to discuss then report back to the larger group
- Written comments are due by May 28, 2015
- Agriculture and Water are the 2 hottest topic areas
- Local discussion included expanding the Green Belt to include CKL and Peterborough; provide farmer incentives for economics; tracking and planning were important.
- One overarching report will be prepared by the end of the Round One

4. Carbon Consultation – Al & Stephen

- With the Province's recent carbon cap and trade direction, will wait to see how it is intended to roll our and it's impact on development and economy
- Proposed 6 month program design
- Copies of AMO position, CCWG & SP CC position papers all provided to CCWG



5. CCAP Update – Jeff

- a) CCAP overview
 - Phase 1 is almost complete, as inventories should be presented by May 2015
 - Target setting to be worked out simultaneously with action planning
 - Phase 1 community engagement in full swing
 - Need to review reduction targets by other municipalities and see where they are at on their targets to find best practices
 - ICLEI will provide a suite of actions with associated targets and criteria to frame conversations and discuss with the Task Forces
 - FCM PCP has a PCP Milestone Model available up to Milestone 2; proposing to build up to 4 with future funding
 - HBM is the only partner municipalities who has not yet signed on to PCP; council unsure of commitment
- b) Community Profiles
 - Will identify historical progress and actions
 - Once data is set, start to look at projects and Business as Usual (BAU)
 - Need to ask municipalities for short term development plan
- c) Update on Community Engagement, Community meetings, Upcoming Events
 - First event was Pop Up Event at 2nd Town Hall on CC and Ag'al, introductory presentation and how to get involved; number of Trent Students interested in participating in some way
 - So far participated in 8 events with 60+ surveys completed; 4 pop up conversations
- d) Timing and Work Plan for Task Forces
 - Launch Task Forces in September 2015 with an intro to the project, provide draft data, need a venue for about 100 people with 8 breakout areas or tables, suggestions include the Lawn Bowling Club, PCVS, PSWC, Lion's Centre or Canoe Museum for 3 – 4 hours
- e) Community CCAP Presentation: Train the Trainer Approach
 - Consider hosting a couple of workshops for Train the Trainer which are easy to run
 - Need to create a tool kit with 3 to 4 activities to run for 1.5 hr workshop
 - Stephen suggested running through his 3rd/4th year course with approximately 35-40 students
 - Also consider as a lunch and learn session with HU, City, MNR, County
