
a) Peterborough, Kawartha, Northumberland Regional Envirothon

d) Curve Lake First Nation

Kaitlyn and I attended Curve Lake's first meeting of the newly formed Environment and Climate Change Committee (ECCC). The Committee has agreed to review and revised the draft CCAP action plan that Kaitlyn has drafted. They have also agreed to look into the missing energy consumption data so that we can finalize the plan.

CLFN also launch an Aboriginal Community Energy Plan (ACEP) in spring 2015. Kaitlyn met with CLFN staff and their consultant to review the status of the ACEP. The ECCC has agreed that both Plans should work together to eliminate duplication and form synergies.

e) Hiawatha First Nation

Kaitlyn and I met with staff at Hiawatha to gather data for their Corporate Sector Inventory and CCAP. A second meeting is set for Dec 13th. They are also considering an ACEP.

f) Climate Change Education in School

We now have 28 teachers registered out of 30 spots available for the Planet Protector Academy that teaches Climate Change, Energy and Transportation to grades 3, 4, & 5 in local schools across the GPA. In 2015/6, 7 teachers participated.

g) CCAP SC Wrap up

To be scheduled for Friday, December 16, 2016 from 2:30 to 4p.m. following the last CCAP presentation to County Council early that morning.

h) Implementation

- Plan to apply for an EcoAction Grant to pay for Kaitlyn for another 1 2 contract plus hire ICLEI to quantify actions completed from 2012 to 2016 for all Corporate and Community plans.
- Plan to apply for an EcoAction Grant with GreenUP and R4G for Project Neutral Peterborough.
