Plan It Peterborough, Peterborough's Official Plan Review: 2016

The Future of Food & Farming Working Group of Sustainable Peterborough is pleased to provide the following comments, including four recommendations, on the first phase of the consultation process for the City of Peterborough Official Plan Review. The Working Group is made up of members representing a wide range of local organizations and interests. A complete list of current members is found at http://sustainablepeterborough.ca

We support the proposed vision that calls for "Peterborough to develop as a complete, linked city that strives to provide for a decent home for everyone, fosters a **sustainable environment**, values its natural and cultural heritage, supports a **strong and diverse economy** and promotes a unique, vibrant sense of place for its residents and visitors. "

We also generally support the proposed **Guiding Principles for the City** that will build:

- 1. A Complete Community: that meets people's needs for daily living throughout their lifetime by providing convenient access to a mix of jobs, services, housing, community infrastructure, open space, and transportation opportunities.
- 2. A Sustainable Environment: that can meet the needs of the present without compromising the ability of future generations to meet their own needs.
- 3. A Unique and Vibrant Sense of Place: that builds on Peterborough's social and physical infrastructure.
- 4. A Linked Community: that recognizes the importance of Peterborough as a social, cultural and economic hub but that must have the ability to move people and goods throughout the city and region.
- 5. A Strong and Diverse Economy: that provides opportunities for all, including its most vulnerable.

However, we would make the following **recommendation** for amendment to the First Guiding Principle:

That the word "food" be added after the work "housing" so that the Principle reads:

A Complete Community: that meets people's needs for daily living throughout their lifetime by providing convenient access to a mix of jobs, services, housing, **food**, community infrastructure, open space, and transportation opportunities.

This amendment will tie the Guiding Principles more directly to section 3.3.18, entitled "Access to Local Food".

We strongly support section 3.3.18, which reads:

"The City will strive to increase production and access to local food sources through the following means:

- a) fostering connections with regional agricultural producers;
- b) supporting the growing of food, sharing of information on nutrition or cooking, and the sharing of produce in local neighbourhoods through community gardens and community kitchens;
- c) supporting the continued operation of the farmers markets in the Central Area and Morrow Park and the creation of a food hub that will enable people of all incomes to meet and to access nutritious food;
- d) supporting the continued use of land for agriculture, until it is needed for development in accordance with this Plan;
- e) considering the use of City land for growing food; and,
- f) encouraging private gardens throughout the community and roof top gardens in higher density locations."

This section builds upon a number of community plans, including the Sustainable Peterborough Plan as it relates to Food and Agriculture, that provide direction for a new Peterborough. It also reflects the extensive research that has been completed to date by Sustainable Peterborough's Future of Food & Farming Working Group and its members, and builds on the outcomes of three Food and Farming Summits held over the past few years. However, we would make the following **recommendations** for adjustment to subsections to b), c) and e):

b) supporting the growing of food, sharing of information on nutrition or cooking, and the sharing of **healthy food and skills** in local neighbourhoods **through initiatives such as cooking programs, food box programs, student nutrition programs and community gardens.**

c) supporting the continued operation of the farmers markets in the Central Area and Morrow Park and enabling the creation of **community food centres and food hubs that will enable**

people of all incomes to meet and to access nutritious food and also enable the aggregation, processing and distribution of food from the local area

e) considering the **expanded** use of City land for growing food;

Subject to the recommendations above, we commend the City for its work to date as it relates to the integration of food into the Official Plan, and look forward to continuing engagement with the review process.

Further to our comments, we would like you to consider the following questions:

- 1. How can we build on and support the work of successful initiatives (including programs and projects led by groups including GreenUp, Peterborough Food Action Network, community gardens, the partnership of the Mount Community Centre and Farms at Work, Nourish Project and Peterborough Public Health) to support neighbourhood-centred planning?
- 2. What role should municipalities play in supporting the development of a complete food system?
- 3. What opportunities can current City of Peterborough grant programs provide to agriculture and food literacy (including growing, cooking, processing) ventures?
- 4. How can the municipality and the development community collaborate to support urban agriculture through such initiatives as community gardens in new developments and in existing neighbourhoods?

The Sustainable Peterborough Working Group on the Future of Food and Farming offers the following recommendations for the SP CCAP:

Our Food

Support localization of the food system

- Establish community food centres and hubs to support the local food economy, and facilitate education and access to healthy food, as well as collaboration and coordination between stakeholders along the food system (growers, processors, buyers, distributors & retailers) [collaboration with all communities]
- Continue to expand the network of community gardens throughout the Greater Peterborough Area and engage the broader community in the value of gardening [all communities]
- Support [local organizations] to provide community skill sharing programs to increase awareness among community members on how to grow, process, and store food [all communities through coordinated effort]
- Support [local organizations] in training, facilitating access to land and promoting successful
 entrepreneurship of new farmers and food business to increase the production and
 processing, distribution and retailing of local food [all communities]
- Update Official Plan policies to support the growing, processing and distribution of locally-produced food for all residents. [City, County, all communities]

Encourage purchasing of locally produced food

• Support and enable the marketing of locally-produced food at the farmgate, at farmers' markets and through a variety of retail outlets and wholesale and institutional purchasers across the Greater Peterborough Area [all communities]

- Support and enable increased wholesale and institutional procurement of locally-produced food across the Greater Peterborough Area [all communities, City, County]
- Support [a variety of local organizations] to continue and expand efforts in support of the previous two actions [all communities, City, County]

Reduce the amount of wasted food

• Implement campaigns and programs to encourage elimination of wasted food at all points along the value chain [all communities, County and City]
