1. Recap from last meeting:

PCP Reporting: James has been working with each Township and First Nation (FN) to collect data to report to the Partners for Climate Protection on progress implementing their Climate Change Action Plans. He is drafting reports on both Corporate and Community GHG emissions data and progress on actions to-date. These reports will help to determine what has changed and how far we've come.

Corn and GHG emission reductions: Sheridan mentioned that corn fields act as carbon sequesters, curbing GHG emissions. Information on acreage of corn in Peterborough is available through the Peterborough Federation of Agriculture. This is based on the notion of "no-till" farming.

2. Roundtable CCAP Progress Updates:

-Some Townships and FNs have taken advantage of IESO's "Save On Energy" energy retrofit incentive programs: https://saveonenergy.ca/

-The County will be rolling out a comprehensive recycling information campaign with the contracting of the new collector, Emterra. Emterra has a stronger focus on proper sorting and recycling 97% of the recycling they manage: https://www.emterra.ca/

Community Data

-Reports are almost the exact same as corporate, but sectors and sources differ slightly. Community data is mid-accuracy because it's challenging to track down definitive numbers.

Community Actions

ICLEI wants to know about community actions, i.e. "participation among the community and decision-making power in reducing GHG emissions". However, it is a consistent challenge to know the kinds of sustainable initiatives that are happening across the community. I.e. community groups, business, residents integrating sustainability into their lives. ORCA has been contacted for information on community initiatives happening in the Townships and First Nations, i.e. Tree planting days, conservation efforts, etc.

Reporting to Councils

Sheridan raised the point of whether each Township and FN should present these reports to their council or to have Sustainable Peterborough do so on their behalf as delegations. This will be discussed on a case by case basis.

4. Potential County-Wide Climate Change Coordinator: Sheridan brought forward the idea of posting a Clean Tech Internship to hire a County-wide Climate Change Coordinator. All attendees were supportive. The position would be minimum one-year, full-time and the candidate must be a recent grad.

Sheridan has drafted a job description and Anna will pass on some other examples from her FCM network.

5. Other Business
