### **Details**

#### Local Government Climate Change Working Group (LGCCWG) Meeting – October 9th, 2019

Chaired LGCCWG to update partners of the progress being made regarding the completion of the Milestone 4 & 5 of the Partners for Climate Protection (PCP) program reporting.

# Green Economy Canada Launch Hub Peer Learning Workshop – November 5, 2019

Attended an all-day peer-learning workshop in Toronto with Brianna Salmon (GreenUP) and members of the New Brunswick GEC hub development team. Learned strategies and techniques to adopt in the creation of Peterborough's hub.

After the workshop, we attended a networking and GEC Evening of Recognition event.

#### Sustainable Peterborough Raw Data Meeting – November 27, 2019

Co-chaired the sub-committee to discuss whether data collected during the CCAP update reports could be made available as open-data for third parties. Enbridge and MTO User Agreements preclude third-party distribution. A motion was made to use the data exclusively for municipal SP partners instead of external or third-parties. Contact will be made with Hydro One, PDI, MTO, and Enbridge to confirm if the data collected can be made available internally.





# Green Economy Canada Business Plan Development - As of November 28, 2019

Currently writing the business plan with Brianna Salmon that will provide a framework for how the Peterborough Hub will operate. In close contact with GEC staff by way of Zoom meetings and email exchanges to finalize the draft business plan by year end.

### Status of Milestone 4 & 5 PCP Submissions – As of November 28, 2019

Corporate reports for Asphodel-Norwood, Trent Lakes, and Otonabee-South Monaghan have been accepted by ICLEI-Canada and are awaiting final approval by the Federation of Canadian Municipalities. The corporate report for Douro-Dummer will be provided to ICLEI-Canada in early-December. Hiawatha and Peterborough County corporate updates are also planned to be submitted by the end of December.

Presently, in the process of resolving a misalignment in community transportation data, which has delayed reporting. Once settled, community reporting will continue with the following reports in varying states of near completion: Asphodel-Norwood, Selwyn, and the City of Peterborough. They are planned to be submitted before the end of December.
